<p>Misconduct 1/26/2023 10:45 AM</p> <p>An OJC occupant repeatedly refused to lock down into their unit.</p>
<p>Misconduct 1/26/2023 10:10 AM</p> <p>An OJC occupant walked away from their pod assignment without authorization or an escort. The occupant was placed in restraints and escorted back to their cell assignment.</p>
<p>Contraband 1/26/2023 11:09 PM</p> <p>An OJC occupant was observed on the recreation yard passing an unknown object to another occupant who dropped the object shortly after. The deputy was able to retrieve the object without incident.</p>
<p>Misconduct 1/26/2023 1:50 PM</p> <p>OJC occupants were observed having a physical altercation in the shower. The deputy gave instructions for them to de-escalate and separate to which they complied.</p>

An OJC occupant struck an OPSO mental health professional while they were assisting another occupant. Nearby OJC staff stopped the occupant from any further striking. The occupant ran into their cell to lockdown.

Two OJC occupants were observed having a physical altercation surrounding the removal of one of their belongings from their cell by the other. One of the occupants dropped an unknown object. The object was retrieved and removed from the pod. Both occupants were escorted to be examined and cleared by medical before returning to the pod.

Two OJC occupants were observed in a verbal altercation over an activity. The exchange between the two became hostile. OJC staff instructed them several times to de-escalate and separate to no avail. The two occupants were seen getting into defensive stances. As OJC staff attempted to step in-between the two occupants, the physical altercation began when one occupant struck the other. Several commands were given to cease the altercation to no avail. OJC staff deployed a burst of OC spray which caused both occupants to comply. Both occupants were escorted to medical for examination and clearing before returning back to the pod.

<p>Misconduct 1/30/2023 5:29 PM</p> <p>An OJC occupant repeatedly refused to follow the instructions they were given.</p>
<p>Use of Force 1/30/2023 3:34 PM</p> <p>An occupant refused their chore assignment to partake in recreation time. The occupant was escorted to their cell to have their cuffs removed. While removing one of the cuffs, the occupant began striking the OJC staff member. Another OJC staff member joined in restraining the occupant to remove the rest of the cuffs from their hands and feet. Once the restraints were removed, the occupant refused medical attention.</p>

The mental health professional and the occupant were escorted to medical for examination and treatment before being cleared to return to their respective assignments.
