<p>Criminal Damage to Property 2/9/2023 2:50 PM</p> <p>An OJC occupant was seen on video, in their cell, tampering with the overhead sprinkler system. That eventually led to water rushing from the cells.</p>
<p>Inmate on Inmate Altercation 2/9/2023 8:45 AM</p> <p>An OJC occupant was seen with a busted lip. Upon further investigation, an OJC staff member reviewed and found evidence of an altercation with another occupant.</p>
